In consideration of my acceptance of my entry, I intend to be legally bound, hereby, for myself, my heirs, my next of kin, executors and administrators, waive, release, forever discharge, hold harmless, and agree not to sue the Christian Surfers Foundation, Safari Surf Shop, it's employees, volunteers, members, organizations, sponsors, agents, leadership, the United States, State of Florida, County of Volusia, or any official connected with this competition, from all liability from injury and/or damage whatsoever, arising from my participation or presence at this surfing competition.
